**ADDENDUM TO THE MoU  
BETWEEN  
THE UNIVERSITY OF PADUA – DEPARTMENT OF PUBLIC, INTERNATIONAL AND  
COMMUNITY LAW  
AND  
THE SAPIR COLLEGE – DEPARTMENT OF LAW  
ACADEMIC YEARS 2024 – 2027**

On the basis of the Memorandum of Understanding signed on March 1<sup>st</sup> 2023, the University of Padua (Italy) and the Sapir Academic College (ISR), agree to implement and finance the mutual exchange of academic staff, researchers, technical-administrative staff and students (at bachelor's, master's and doctoral level) [and/or any other academic activities to be specified in the following article no. 1.2].

**Article I.**

**1 – Mobility**

For each of the academic years of validity of this Addendum, the Parties agree to exchange a max. no. of 6 guests (4 professors and 2 students) coming from each of the two Institutions; the max. duration of stay for each guest is established in the no. of max 4 months per professor and the no. max of 4 months per student.

The sending University shall select its own exchange participants, whose selection will have to be approved by the hosting University; the duration and the starting date of the visit shall be agreed by the Parties.

The participants' names, study/academic plan and arrival date shall be communicated to the hosting University by post, e-mail or fax at least two months before the starting date of the visit; the hosting University shall communicate its being available to host the selected guests within one month upon receipt of the information.

The hosting University shall not be considered responsible for the unfavourable effects arising from the delay of the communication or for any other inconvenience due to the sending University.

**2 – Other activities**

The Parties will examine and develop joint courses, either as regular or crash courses, retreats and summer schools.

**Article II – Financing**

Upon availability of funds, the University of Origin shall cover travel, board and accommodation expenses incurred by the guests. In the case of unavailability of funds, all expenses connected to the mobility period will be in charge of exchange participants.

### Article III – Coming into force and term

This Addendum, which will have to be coherent with the rules of the connected Memorandum of Understanding, shall be effective as of the latest signature date below and shall remain in force for a period of 4 years following this date, unless written notice is given by either Party; it shall in any case not remain in force after the expiration date of the connected Memorandum of Understanding. The notice shall take effect three months after the date of notification to the other Party. Nevertheless, the activities in progress in the framework of this Addendum shall not be compromised by the notice and shall be normally concluded.

This Addendum is executed in a set of two copies, both written in English language, and each institution retains one copy. The Agreement may be executed by exchange of a signed and scanned signature pages in PDF format.
