**ADDENDUM TO THE MoU
BETWEEN
THE UNIVERSITY OF PADUA – DEPARTMENT OF PUBLIC, INTERNATIONAL AND
COMMUNITY LAW
AND
THE WAKE FOREST UNIVERSITY SCHOOL OF LAW
ACADEMIC YEARS 2022 –2027**

On the basis of the Memorandum of Understanding signed on April 14th 2023, the University of Padua (Italy) and the Wake Forest University, on behalf of its School of Law, Winston-Salem, North Carolina, (USA), agree to implement and finance the mutual exchange of students pursuing degrees in law.

Article I - Exchange

For each of the academic years of validity of this Addendum, the Parties agree to exchange a maximum number of 2 students coming from each of the two Institutions; the maximum duration of stay for each student is established in the number of 5 months.

The sending University shall select its own exchange participants, whose selection will have to be approved by the hosting University; the duration and the starting date of the visit shall be agreed by the Parties.

The participants' names, study plan/research topics and arrival date shall be communicated to the hosting University by post, e-mail or fax at least two months before the starting date of the visit; the hosting University shall communicate its being available to host the selected guests within one month upon receipt of the information.

The hosting University shall not be considered responsible for the unfavorable effects arising from the delay of the communication or for any other inconvenience due to the sending University. As specific contact at the host institution, the University of Padua names Prof. Bernardo Cortese and Wake Forest University School of Law names Associate Dean Prof. Richard Schneider.

The exchange students will be admitted to graded courses held at the host institution: the host University will release to the student, at the end of his/her visit period, a Transcript of records (Statement of results) which shall include the list of all courses completed by the student and information about the number of credits and the grades obtained. The sending institution will then determine the number of credits and the grades recognized in their own system of credits.

Article II – Expenses

Participating students will pay their ordinarily applicable tuition and fees to their school of record (i.e. the sending University), and shall be exempted from the payment of tuition and fees at the hosting University. The Parties agree that round-trip travel, board and accommodation expenses and every other expense connected to the period of study abroad (including but not limited to medical or accident insurance) shall be covered by the student.

Article III – Term

This Addendum, which will have to be coherent with the rules of the connected Memorandum of Understanding, shall be effective as of the latest signature date below and shall remain in force for a period of 5 years following this date, unless written notice is given by either Party; it shall in any case not remain in force after the expiration date of the connected Memorandum of Understanding. The notice shall take effect three months after the date of notification to the other Party. Nevertheless, the activities in progress in the framework of this Memorandum shall not be compromised by the notice and shall be normally concluded.

This Addendum is drafted in English. Each Party shall keep one original copy. The Agreement may be executed by exchange of a signed and scanned signature pages in PDF format.
